BY SHOWCASING THE TALENTS OUR SERVICE DOGS HAVE, WE ARE ABLE TO PROVIDE A NEW SENSE OF INDEPENDENCE TO OUR RECIPIENTS AS WELL AS THEIR FAMILIES AND/OR PARTNER'S LIVES THAT THEY MAY NOT HAVE HAD IN THE PAST. RETRIEVING FREEDOM CHANGES LIVES EVERY DAY WITH THEIR VOLUNTEER AND COLLEGE IMPACT PROGRAMS THAT ASSIST IN THE TRAINING AND RAISING OF THE SERVICE DOGS WHILE IN TRAINING. IN 2019, RFI WAS ABLE TO PLACE 11 DOGS TO FAMILIES WHO HAVE A CHILD WITH AUTISM, AND PLACED 14 DOGS WITH VETERANS SUFFERING FROM PTSD, PHYSICAL OR MOBILITY CHALLENGES.
